I understand non-refundable entry fees are \$20.00 for members and \$30.00 for non-members and that the completed entry form, entry fee, and entered artwork must be received by GACA between August 23 -26, 2022 by 2:00 p.m.(EST) to be considered eligible. I also, understand that all flat works must be matted and/or framed and wired (ready to hang) with no sawtooth hangers. All pieces must be labeled on the back or in another hidden spot with the artists' name, title, medium and sale price. I agree to leave accepted entries on display in the GACA Center for the duration of this exhibit. I understand that acceptance into the show is based on the juror's discretion and GACA has the right to reject any submission for any reason. I understand that GACA will retain a 30% commission on any item sold during this show and that GACA reserves the right to refuse any entry for any reason and all pieces not accepted into the exhibit must be picked up by September 9, 2023 or if accepted into the Exhibit and unsold must be picked up between November 1- 4, 2023 or they will become property of GACA. GACA has my permission to photograph art work for publicity or archival purposes. I also understand that GACA will take reasonable precautions to ensure the protection of my artwork appearing in this show, but I am exhibiting at my own risk. I understand that I can obtain insurance on my own for my artwork in this show and that GACA does not insure exhibitor's art and GACA is not responsible for loss or damage to artwork appearing in this show.
